General Price List

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. These prices are effective March 1, 2022, and are subject to change without notice. All costs are determined when services are provided.

PROFESSIONAL SERVICES

Basic services of funeral director and staff \$ 2,095.00

Our charge includes responding to initial requests for service, conducting the arrangement conference, securing necessary permits, documents and authorizations, preparing notices, temporarily sheltering the deceased, and coordinating the arrangements with the cemetery, crematory or third parties. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This charge is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)

Embalming \$ 675.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. In the interest of public health, this funeral home requires embalming if the deceased is to be encountered for any category of viewing, except identification, which can be made by way of photograph to limit OSHA regulated exposure risks of encountering any biohazardous substance, if embalming is expressly declined.

Alternative sanitary care of the deceased \$ 350.00

This is the holding of the deceased for burial or cremation for up to 7 days when embalming is not elected. A \$50.00 daily surcharge applies for refrigeration after 7 days. An unembalmed body presents a health hazard to our employees and to the general public. The deceased is placed in an especially designed refrigeration room.

Other preparation of the body \$ 225.00

This includes applying cosmetics, dressing and placing the deceased in a casket. (A hairdresser or barber, if desired is not included in this fee).

Autopsy / Anatomical Gift / Trauma Reconstruction \$133.00/hr. up to 3 hours or \$ 399.00

Additional use of professional staff to execute custom service orders \$ 150.00/hr

Additional use of associate staff to execute custom service orders \$ 50.00/hr

Our involvement in the service will also ensure a timely commencement and conclusion of a memorial service. Our staff members are specially trained to extend hospitality to guests, make announcements, provide umbrellas, water, tissues, and generally provide for family and guest comfort.

Priority Cremation \$ 545.00

DIRECT CREMATION

The charge for a basic cremation includes the local transfer of the remains, necessary authorizations, basic services of the staff, and sheltering the deceased. This charge also includes priority cremation. This charge does not include the use of staff and facilities for any visitation or ceremony, public or private. If you want to arrange for a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made out of materials like fiberboard or composition materials (with or without an outside covering).

Direct cremation at Geib's Tuscarawas Valley Crematory, basic services of director, alternate sanitary care, transfer of deceased, refrigeration of unembalmed body up to 10 days, and with cremation container provided by purchaser \$ 3,095.00

Direct cremation with basic cremation container provided by our funeral home \$ 3,175.00

Direct cremation with crematable casket selected from our funeral home (the cost of the casket is not included) From \$ 3,095.00

SIMPLE CREMATION

The charge for a Simple Cremation includes the local transfer of the remains, necessary authorizations, basic services of the staff, sheltering of the deceased, embalming, dressing and casketing, the priority cremation, private viewing option (up to 1 hour, Monday-Friday 9am – 4 pm).

Simple cremation with the transporter provided by our funeral home \$ 4,300.00

IMMEDIATE BURIAL

The charge for immediate burial includes the local transfer of remains, embalming or alternate sanitary care, the basic services of staff, completing and securing necessary authorizations, and transportation to a local cemetery. The charge does not include the use of staff or facilities for any viewing, visitation or ceremony prior to burial.

Immediate burial with casket provided by purchaser \$ 3,515.00

Immediate burial with a casket selected from our funeral home (the cost of the casket is not included) \$ 3,515.00

Forwarding of Remains to Another Funeral Home \$ 3,265.00

This charge includes basic services of funeral director and staff, transfer of the deceased from the place of death (non extenuating circumstances), embalming, completing and securing the necessary certificates and permits. This charge does not include any merchandise, shipping charges, airport transportation, or the use of staff and facilities for any viewing, visitation or ceremony.

Receiving Remains from Another Funeral Home \$ 2,840.00

This charge includes basic services of funeral director and staff, local transportation of the casketed decedent to the funeral home, use of the preparation room and transportation to a local cemetery or crematory. This charge is exclusive of any shipping or other transportation charges, any merchandise, or the use of the staff and facilities for any viewing, visitation or ceremony. Any deviation from this package will necessitate the use of itemization for our services.

CHILDREN'S CARE

Because We Care...our professional services for infants under one year of age are provided to the family at no charge. When the Geib team is called upon to serve children between the ages of one and ten, our Professional service of funeral director and staff charge (\$2095) will be waived. Services and merchandise are priced as noted within the General Price List.
